As such, it is ideal for the lamination of markings and decorations, protecting them from any permanent damage that would otherwise result from exposure to graffiti, including spray paints, felt-tip marker pens and other staining agents. In conjunction with IP 2840-106, graffiti can be easily removed with the help of common solvents or proprietary cleaning products such as IP Surface Cleaner and/or IP Magic Clean. As a 100% PET product, it will also present a “greener” laminate solution for end-users who are looking to add environmentally-friendly credibility to their output than would otherwise be presented with more standard PVC laminate options. It is also a very effective solution for paper lamination specifically, providing protection for photographic and graphic prints, including commercial poster prints. It is supported on a clear polyester release liner that provides complete visual inspection of the product, easy liner removal and a distortion-free adhesive surface with high levels of clarity in application. Please note that IP 2840-106 is not suitable for application to apolar, low-energy surfaces (including PE and PP) and it should only be used on flat surfaces. **IMPORTANT:** This special laminate is impervious to gas and moisture and it is essential that the print media is completely dry prior to application of this laminate.
